Subject: TIGT GRAND ISLAND NORTH DIRECTIONAL NOTICE **UPDATE #1**

The Directional Notice is being revised to also include BHGD/TIGT HUSKER AG 2 PIERCE (Location 44172) and BHGD/TIGT PREFERRED SANDS OF GENOA (Location 44573)

Tallgrass Interstate Gas Transmission (TIGT) has experienced a Force Majeure event at the Grand Island compressor station that coupled with strong load demand due to the significantly colder weather in Nebraska threatens to impact system pressures on Segments 410, 420, and 430. Consequently, TIGT is issuing a Directional Notice pursuant to Section 33.5 of its tariff to maintain system integrity north of Grand Island. It is estimated that this Directional Notice will be in effect for multiple days depending upon the weather and operating conditions.

TIGT directs all load at the following locations to limit gas consumption to 1,500 Dth as of ID2 on Gas Day December 22, 2022 and until further notice.

BHGD/TIGT GREEN PLAINS ATKINSON (Location 42543)

BHGD/TIGT HUSKER AG ETHANOL PLT PIER (Location 40785)

BHGD/TIGT HUSKER AG 2 PIERCE (Location 44172)

BHGD/TIGT VALERO RENEWABLES ALBION (Location 42650)

BHGD/TIGT PREFERRED SANDS OF GENOA (Location 44573)

Industrial load behind BLK HILL/TIGT NORFOLK TBS #2 MADI (Location 15149)

For the avoidance of doubt, on Gas Day December 22, 2022, affected shippers shall not take more than 1,500 Dth commencing in ID2 through the rest of the gas day. For each subsequent Gas Day, the limit shall be 1,500 Dth/d. In addition, no authorized Overruns are allowed. Shippers failing to comply with this Directional Notice shall be subject to a penalty of six dollars (\$6.00) per dekatherm for quantities in excess of 5% of 1,500 dth.

All other TIGT charges/penalties are still applicable.
