### Notice Text:

El Paso Natural Gas (EPNG) has issued a warning regarding a possible Strained Operating Condition (SOC) due to a high line pack condition. Southwest Gas Corporation (Southwest) requires transportation customers to match or nominate less gas than projected usage. Southwest requires that transportation customers in Arizona closely monitor their nominations and scheduled quantities versus usage. If conditions do not improve an actual SOC may be declared by EPNG resulting in potential upstream pipeline charges and a reduced imbalance tolerance for all transportation customers who transport natural gas supplies on EPNG.
