## Notice of Wisconsin Gas LLC High Flow Constraint - ANR Supply Pool

December 30, 2025

Dear Valued Customer,

Please be aware that Wisconsin Gas LLC ("WGC") has issued a High Flow Constraint ("HFC") applicable to Symmetry's delivery of natural gas to you under our agreement, effective December 30, 2025 and continuing until further notice. This HFC applies **ONLY** to **Interruptible service** customers within WGC's **ANR supply pool**.

Information regarding the referenced HFC may be found on our website at <https://symmetryenergy.com/notices/>, which will be updated periodically. For more information or questions regarding the HFC and its potential impacts, we encourage you to contact your Transporter directly.

Please note, while an HFC is in effect, both you and Symmetry are required to comply with the applicable provisions of the HFC. Failure to comply may result in the Transporter assessing imbalance penalties, fines, and/or other charges for which you may be responsible. Additionally, our agreement provides that Symmetry may charge you for incremental gas you consume during an HFC period at market prices, which may be high. Also be aware that while the HFC is in effect, Symmetry will have no contractual duty or ability to credit or repurchase any portion of your natural gas contract quantities.

Penalties assessed by a Transporter can be substantial and we encourage you to monitor and manage your daily gas usage for the duration of the HFC.

It is critically important during the HFC that you inform us immediately of any plans to make significant operational changes, including meaningful alterations to your usage compared to your First of Month (FOM) nominations. Symmetry is required to balance all gas receipts and deliveries during the HFC and must receive timely information from you regarding material changes in your gas usage.

Symmetry appreciates your compliance and prompt attention to this important matter and will endeavor to work with you to mitigate adverse impacts of the HFC.
